

**The Crafts Dept. Blog Mother's Day Craft and Giveaway  
OFFICIAL RULES**

These Official Rules apply for Mother's Day Craft and Giveaway promotion ("Sweepstakes") conducted by Martha Stewart Living Omnimedia, Inc. ("MSLO"), 601 West 26th Street, 10th Floor, New York, New York 10001 ("Sponsor") which will be promoted at <http://thecraftsdept.marthastewart.com> ("Website"). The Sweepstakes will start at 10:00 AM Eastern Daylight Savings Time ("EDT") on April 27, 2011 and will end at 6:00 PM EDT on April 29, 2011 ("Promotion Period"). By entering this Sweepstakes, you agree to the Terms in these Official Rules.

**1. SWEEPSTAKES ENTRANTS AND PRIZE RECIPIENTS MUST BE BOTH (A) LEGAL RESIDENTS OF ONE (1) OF THE FIFTY (50) UNITED STATES OR THE DISTRICT OF COLUMBIA, AND (B) AGED 18 YEARS OR OLDER AT THE TIME OF ENTRY TO BE ELIGIBLE. VOID OUTSIDE THE UNITED STATES AND THE DISTRICT OF COLUMBIA, AND WHERE PROHIBITED BY LAW. Incomplete, unreadable, inaccurate, unintelligible or late Entries which otherwise do not comply with these Official Rules will be disqualified. Your Entry constitutes your consent to participate in this Sweepstakes and your consent for Sponsor to obtain and deliver your name, address and other information to prize supplier for the purpose of administering this Sweepstakes and for other uses by Sponsor as permitted by applicable law. Entries are the property of the Sponsor and will not be acknowledged or returned.

a. Restrictions:

- The Entry must not disparage Sponsor, Released Entities or any other person or party affiliated with the Sweepstakes;
- The Entry must not contain brand names or trademarks other than those owned by Sponsor, which entrant has a limited license to use to incorporate in his/her Entry in this Sweepstakes;
- The Entry must not contain material that is inappropriate, indecent, obscene, hateful, tortuous, defamatory, slanderous or libelous;
- The Entry must not contain material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation or age; and
- The Entry must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any state where Entry is created.

**3. SELECTION OF WINNERS/RANDOM DRAWING:** Potential prize winners will be selected in a random drawing from among all eligible Entries received. The random drawing will be conducted after 6:00 PM EDT on April 29 on or about May 2, 2011 by Sponsor whose decisions are final and binding in all respects pertaining to this Sweepstakes. Odds of winning depend on the number of eligible Entries received. Limit one (1) prize per household.

**4. TWO (2) PRIZES:** Each prize consists of one (1) Martha Stewart Screw Punch and one (1) Martha Stewart Crafts Essential Colors Glitter Set (24 pack). The approximate retail value ("ARV") of each prize is \$54.98. Total ARV of all prizes is \$109.96. error as may give an erroneous indication that a prize has been won.
