OFFICIAL RULES**

**NO SUBSCRIPTION, ONLINE ENTRY OR PURCHASE REQUIRED TO ENTER OR RECEIVE A PRIZE.
A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.**

These Official Rules apply for The Crafts Dept. Blog Plaid Giveaway promotion ("Sweepstakes") conducted by Martha Stewart Living Omnimedia, Inc. ("MSLO"), 601 West 26th Street, 10th Floor, New York, New York 10001 ("Sponsor") which will be promoted at <http://thecraftsdept.marthastewart.com> ("Website"). The Sweepstakes will start at 2:00 PM Eastern Daylight Savings Time ("EDT") on August 24, 2011 and will end at 6:00 PM EDT on August 26, 2011 ("Promotion Period"). By entering this Sweepstakes, you agree to the Terms in these Official Rules.

1. SWEEPSTAKES ENTRANTS AND PRIZE RECIPIENT MUST BE BOTH (A) LEGAL RESIDENTS OF ONE (1) OF THE FIFTY (50) UNITED STATES OR THE DISTRICT OF COLUMBIA, AND (B) AGED 18 YEARS OR OLDER AT THE TIME OF ENTRY TO BE ELIGIBLE. VOID OUTSIDE THE UNITED STATES AND THE DISTRICT OF COLUMBIA, AND WHERE PROHIBITED BY LAW. SWEEPSTAKES SUBJECT TO ALL APPLICABLE FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS. The random drawing will be conducted after 6:00 PM EDT on August 26, 2011 by Sponsor whose decisions are final and binding in all respects pertaining to this Sweepstakes.
